

Irish Méndez Centre for Investigative Interviewing

Launched on 18 September by Prof. Yvonne Daly of DCU School of Law and Government and Dr. Alan Cusack of the University of Limerick School Of Law. This new center is dedicated to advancing the art and science of investigative interviewing, enhancing best practices, and providing world-class training to professionals in law enforcement, legal sectors, and beyond. This significant event was attended by the representatives An Garda Síochána (the police), the Corporate Enforcement Authority, the Garda Síochána Ombudsman Commission, the Central Bank, Revenue, Tusla (the Child and Family Agency), lawyers, interpreters, prosecutors, judges, policy-makers, and academics. During the opening, a new book "Police Custody in Ireland", edited by Prof. Daly, was promoted. The book is available here.

ImpleMéndez MC Meeting in Coimbra

Between 14-16 May, 40 members of ImpleMéndez met in the beautiful, historic University of Coimbra, Portugal, to work on our ongoing mission to support the implementation of the Méndez Principles on Effective Interviewing and Information-Gathering.

Slovenia Training School

Our 1st ever Training School took place in the beautiful city of Ljubljana, Slovenia, on 2-3 July. 27 members of our growing international network gathered together, across disciplines and jurisdictions, under the theme of "Implementing the Méndez Principles in Suspect Interviews." Priority was given to "young researchers" as participants, and those in attendance were primarily academic colleagues from law, psychology, criminology, policing studies, forensic linguistics, translation and interpreting, and social work.

Norwegian Méndez Centre for Investigative Interviewing

Launched on 16 September at the Faculty of Law, University of Oslo. ImpleMéndez project overview was presented by Prof. Dave Walsh. Prof. Emily Alison discussed the critical need for police to invest in improved communication skills for better outcomes in investigations. Profs. Julia Korkman and Olafur Bragason emphasized the importance of regional cooperation in adopting investigative interviewing practices aligned with the Méndez Principles. Profs. Ray Bull, Becky Milne, and Dr. Ivar Fahsing explored the impact of investigative interviewing training programs and shared Norwegian statistics showing the integration of the KREATIV investigative model into police practices. Dr. Asbjørn Rachlew and Prof. Lennart May led a discussion on challenges faced across Europe, such as mitigating undue pressure on vulnerable suspects, including minors. Pre-recorded opening remarks were delivered by Prof. Juan E. Méndez, who underlined the significance of the initiative. Closing remarks were provided by Gisle Kvanvig and Susanne Flølo from the Norwegian Centre for Human Rights.

Liverpool Project Building and Development Workshop

On 10-11 September, the Impleméndez COST Action Project Leads came together in Liverpool for an intensive Project Building and Development Workshop. The event focused on strengthening collaboration, refining strategies, and planning future actions across our network. Attendees shared insights, best practices, and innovative ideas, laying the groundwork for impactful projects in the upcoming phases.

Last but not least...

- Between 26-27 March in Warsaw there was a meeting where the WG leads and co-leads met with other members of the CM group to undertake initial strategic planning for ImpleMendez;
- A network meeting also took place in Reykjavik on 14-15 October at the Icelandic National Police Academy;

A special contribution...

Investigating rape and sexual assault in marital relationships

Gisèle Pelicot, the 72-year-old, sexually violated and raped in her home from 2011-2020 stood in a French open court to testify against her former husband, Dominique and 50 other men. In France, *proof of intent* is required to secure a conviction of rape. Gisèle was drugged by her husband during the prolonged and repeated abuse. Currently, 17 men who have been convicted are claiming they were

"manipulated" by Pelicot into raping his wife and assumed she had given consent.

Dominique pleaded guilty in 2020 following his arrest for another sexual offence. Two cold cases, a rape/murder case from 1991 and an attempted rape in 1999 at which Dominque's DNA was found have now been reopened. If the evidence from those cases had been fully investigated perhaps Gisèle would have been spared.

Statistics from the Institut des Politiques Publiques¹ in France over a 10-year period indicate there were more than 400,000 cases of sexual violence in France with only 13% resulting in a conviction (April 2024). These data do not look separately at prosecutions of rape in relationships and marriages (vs stranger or date rape) but in each case one assumes there is insufficient evidence.

We have in the **Méndez Principles** an international standard for the investigation of crime, one that respects the rights of individual victims and witnesses. **Principle 3** speaks directly on identifying vulnerability, at the individual and situational level. This has direct application where a victim may be in an abusive long-term relationship, fearful of blame or some other punishment. An investigator trained in the use of **Méndez Principles** would bring the skills of establishing a rapport, encouraging the witness to talk freely, actively listening and getting a full account without any judgment.

The powerful impact of Gisèle Pelicot's bravery makes clear that we need to change attitudes, to address head-on the misogyny and patriarchy that are barriers for victims. My hope is that **ImpleMéndez** can also bring about a cultural shift among police and legal practitioners in investigations of rape and abuse in relationships. **Dr Amina Memon**
