Latest Developments

Workshop and Network Building meetings in Warsaw

Six ImpleMendez members also met senior representatives of the Polish Ministry of Justice and in a separate meeting a Polish journalist from the country's leading media outlet. During the meeting in the Ministry's webpage here, the participants discussed perspectives for Poland on the implementation of the Principles and identify ways for future collaboration. The information about the meeting was published on the Ministry's webpage here. The meeting with the Polish journalist was a great opportunity to promote our Action and the Principles in national media. The participants talked about miscarriages of justice, why they happen, and science-based interviewing techniques. Both meetings were kindly organized by our colleague Olga Mazur (massive thanks there!).







Online WG1, WG2, WG3 and MC meetings

On 18.02. 2025, **WG1** convened online to review key project developments and explore new collaborative opportunities within ImpleMéndez. The meeting featured presentations on initiatives including "From Conflict to Court Room", "Investigative Interviewing of Human Trafficking Victims", and "Child Interviewing and Mendez Principles CIMP", highlighting significant progress. Discussions also focused on integrating research components into our training programmes and enhancing teaching materials to optimize project outcomes. Additionally, the group considered a proposal for a Special Edition in the Journal of Investigative Psychology and Offender Profiling. The next WG1 meeting is scheduled for 4.09.2025.

On 05.02.2025, members of **WG2** met online to discuss possibilities for networking within the group. Three ongoing projects were presented – "Expanding the Accessibility of the Mendez Principles: Piloting Translation and Dissemination Processes Across COST Country Languages", the launch of the Irish Mendez Centre for Investigative Interviewing, and "From Principles to Practice: Achieving Bias-Free Investigative Interviewing through Mendez Principles Training and Guidance". Next meeting of WG2 is scheduled on 10 September 2025 (14:00 CET). On the same day, an **MC meeting** was held online with the participation of COST representatives, who introduced changes in the reimbursement policy for 2025 (published on the **COST website here**).

On 12.02.2025, members of **WG3** met online to catch up on the ongoing and upcoming projects within Implemendez. In addition, a survey was circulated to assess who wants to get involved/in touch on certain specific vulnerability related topics. The survey can still be filled out by via **this link**. The next meeting will be held on Friday 5 September at 10:00 CET.

WG4 is active in efforts to bridge the gap between academic research and practitioners. It faces numerous challenges such as interdisciplinary collaboration, funding, and scalability through the engagement of the national stakeholders, pilot programs, and continuous evaluation. It seeks to create sustainable, scalable, and effective solutions for real-world challenges. WG4 aspires to shape a more innovative, inclusive, and policy-driven future.
