# Statement from the Méndez Principles Steering Committee Co-Chairs

The Co-Chairs of the Steering Committee of Experts for the Principles on Effective Interviewing for Investigations and Information Gathering have issued a statement marking four years since the launch of the Principles. The statement reflects on the progress made and encourages others to assess and share their own experiences with implementing the Principles. # **Latest developments**

#### Irish Méndez Centre

In April, the Irish Méndez Centre for Investigative Interviewing hosted two significant events advancing ethical and evidence-based interviewing practices.

- April 16, 2025: The Centre conducted a one-day training session for members of An Garda Síochána (the Irish police). The training focused on rapport-based interviewing techniques and the application of the ORBIT framework, aimed at enhancing the quality and reliability of investigative interviews.
- **April 28, 2025:** An expert knowledge exchange event was held at the Trinity College Institute for Neuroscience, focusing on the functioning of memory and psychological insights on investigative interviewing.

These events reflect the Centre's ongoing commitment to capacity-building, professional development, and the implementation of the Méndez Principles in Ireland.

#### Conference in Rzeszów

Our colleagues, Denis Solodov and Olga Mazur (Poland), took part in the prestigious international conference on forensic sciences organized by the University of Rzeszów and the Polish Forensic Science Society. The presentations covered the use of artificial intelligence in assisting the preparation of forensic expert interviews (D. Solodov), and the impact of investigator training on the interrogation strategies used with suspects. The presentations (after appropriate redaction) will be published as chapters in a monograph by a renowned publishing house.

#### **Events in Bucharest, Romania**

On May 7-8 2025 several our Action members were involved with events in Bucharest (Romania). On May 7, Valentina Cadelo (APT) collaborated with key criminal justice professionals to support the completion of the Romanian translation of the Méndez Principles. Across both days, two parallel training schools were conducted:

- "Introduction to the Méndez Principles", led by Coral Dando, Ray Bull, and Dave Walsh;
- "Introduction to the Méndez Principles in Adult Witness Interviews", led by Amina Memon, George Visu, and Kristjan Kask.

These events represent an important step forward in promoting effective and ethical interviewing practices within Romania's criminal justice system



## Meetings in Malmö, Sweden

On May 6-7, 2025, several members of our Action gathered in Malmö, Sweden, for a series of collaborative meetings. On May 6, one group-comprising members from different countries-focused nine exploring the potential establishment of a Nordic-Baltic Méndez Centre Investigative Interviewing. Meanwhile, other participants met on both May 6 and 7 to discuss the barriers and enablers to implementation within the context of their ongoing projects under the Action. These meetings provided a valuable opportunity for strategic dialogue and cross-border collaboration to advance the goals of the Méndez Principles.





# **Conference in Freiburg**

On May 15-16, 2025, the Conference on Guidelines for Effective and Fair Interviewing in Criminal Proceedings took place in Freiburg, Germany. The event featured 18 distinguished speakers and panelistsincluding Juan Méndez, Ivar Fahsing, and Milne-and was attended Rebecca approximately 50 high-ranking legal across professionals from Germany, practitioners, including judges, legal researchers, and policymakers.

### Live Webinar on Technology in Investigative Interviewing

On Tuesday, 13 May 2025, a live webinar titled "The Use of Technology in Investigative Interviewing" was held in collaboration with the International Investigative Interviewing Research Group (iIIRG). The session featured expert presentations from ImpleMéndez members Dr. Kate Haworth, Dr. Brandon May, and Adrian Gates, who shared cutting-edge insights into how emerging technologies are transforming investigative interviewing practices. Topics included the integration of digital tools, remote interviewing methods, and ethical considerations in tech-assisted interviews. The webinar drew strong interest from practitioners, researchers, and students across time zones, highlighting the growing relevance of technology in modern criminal justice systems.

In addition to the quality and relevance of submitted abstracts, priority will be given to those who:

- Commit to participating in an ImpleMéndez workshop at the conference, and
- Contribute to a report relating to their area of expertise and the Méndez Principles.

- 1. A statement confirming that you wish to be considered for a reimbursed place;
- 2. Your age (to confirm if you qualify as a young researcher);

- 4. Confirmation of your willingness to participate in the ImpleMéndez workshop and contribute to the related report.


